6.	Parish Updates: Coronation Hall:
	The Parish received an update on the Coronation Hall, provided by Mr William Clemence, Chairman of the Village
	Hall, as part of the Grafton Annual Parish Meeting
	Action: Mrs Whitcher to update the Council on the Coronation Hall at the next Parish meeting.
	Playing Field Maintenance:
	Placing signage "Take your rubbish home": Mr Hatherell announced the signage is now ready to be installed at
	the Playing Fields. Mr Lemon offered his assistance.
	Action: Mr Hatherell to confirm that the signage has been installed at the Playing fields.
	Speed Watch/SID: Mr Hatherell noted difficulty to organize the Speed Watch sessions due to the busy schedules
	of volunteers. He said a Speed Watch session was planned for the following week.
	Action: Mr Hatherell is to update on the ongoings of the Speed Watch and SID next meeting.
	PCAP: An annual update was presented by Mrs Brew at Grafton Annual Parish meeting.
	Action: Mr Pash to update on the PCAP next scheduled meeting.
	Defibrillators: Mr Burke suggested that the Parish needs only to obtain one pair of spare defibrillators pads, as all
	deployed pads are still within usable dates. The Defibrillator team are still working through the issues raised by

the one supplier and updating all of the defibrillators units in the Parish to the same code and registering this on the national database.
Action: Mr Hosier to report on defibrillator progress and sharing the same access code for all defibrillators units in this Parish at the next meeting
Community Calendar: The updated community was emailed prior to the meeting by Mr Nelson.
Action: Mr Nelson to publish any updates on the web site.
Rounders plans: Mrs Whitcher confirmed plans for Rounders are well under way. She raised the request for the
grass on the green to be cut and the cuttings to be collected and disposed. The Parish agreed that any profits
raised would go towards the parish fireworks later this year.
Action: Mrs Whitcher to present outcome of the Rounders next scheduled meeting.
Neighbourhood Plan (NP): Mr Pash explained that due to progress made on the Neighbourhood Plan that he
recommended to proceed with the Section 14 Consultation. He guided the committee through the process;
shared materials as follows:
Compiled email list of statutory consultees was set. Each consultee receives an email from Monday 19
May from the clerk. Proposed dates for consultation for seven weeks from 19 June to 7 July 2025.
 Google survey was shared, for members of public. The advert of the survey will be printed and
distributed on the notice boards in the parish, printed in the community news and delivered to each
household and published on the website.
 Proposed NP published on website. Printed copy of NP available for the public in the Swan Inn, Wilton, with ability for paper copies of survey to be completed and returned there.
It was agreed to proceed with the Section 14 Consultation, proposed by Mr Hosier, seconded by Mr Nelson. Mr
Pash asked the clerk to send the requested emails.
Action: Mr Pash to brief on the NP progress at the next scheduled meeting.
Parish Steward: Mr Lemon had no updates on parish steward.
Road situation in West Grafton: Mrs Whitcher announced that the ditch in West Grafton had been dug out.
The potholes and gully clearing are still in process.
Action: Mr Lemon and Mrs Whitcher to report on any updates.
Parish Website: Mr Pash informed the committee that the Parish website is fully functioning following the web
and domain hosting being transferred to a new provider.
Action: None. The matter is now closed.
Recruitment of Parish Clerk: Miss Vonsova announced her resignation due to other commitments.
Action: The Parish Council are to recruit a new clerk as soon as possible. Advertisements will be placed in the
newsletter, on the website and on the Parish WhatsApp groups.
AOB: Mr Lemon showed the committee his Resistance Plan for Wilton in case of emergencies.
